LIT 2000: Introduction to Literature

Course Description

This course examines the unique and changing role literature has played in individuals' lives and in society. It is centered on three deceptively simple questions: What is literature? Why do we write literature? And why do we read literature? It introduces students to a range of literary genres from different countries and historical periods.

The primary aim of this course is to help students develop the critical skills of analysis and interpretation. Students will also learn how formal and stylistic elements as well as historical context shape the meaning and significance of literature. By developing skills for reading literature and identifying literary contexts, students will develop their ability to decipher meaning from language and better understand their own interactions with science, technology, media, commerce, and politics.

Course Objectives

In addition to gaining a deeper appreciation of the expressive potential of language and the varieties of literature, students will develop a broader cultural literacy and an understanding of the changing definition and role of literature in society.

Therefore, by the conclusion of the course it is expected that students will be able to:

- 1. Demonstrate content knowledge of specific literary works and the structures and conventions of different literary genres.
- 2. Produce original, critical readings of literary texts, using different methods of interpretation and analysis, while identifying and interpreting formal and genre-related elements in the texts.
- 3. Critically assess the variety of roles that literature has played historically and continues to play in the human experience.
- 4. Draw connections between literary texts and their biographical, historical, and cultural contexts of authorship and reading.

General Education Designation

This course fulfills three credit hours of Humanities (H) requirements. Humanities courses provide instruction in the history, key themes, principles, terminology, and theory or methodologies used within a humanities discipline or the humanities in general. Students will learn to identify and to analyze the key elements, biases and influences that shape thought. These courses emphasize clear and effective analysis and approach issues and problems from multiple perspectives.

Required Texts

Shorter texts and excerpts will be provided to students via Canvas.

Attendance & Participation (100 points)

Attendance: Attendance is mandatory and will be assessed by class roll or sign-up sheet. After two unexcused absences, students will lose 1% from their final grade for every additional unexcused absence. Absences will be excused in accordance with UF policy. Acceptable reasons include illness, religious holidays, military obligation, and the twelve-day rule. Should you miss a class for any reason, you are responsible for informing yourself as to what was covered in class. Participation: Students are expected to review the assigned readings before class. Each week will begin with a series of basic questions on the contents of the assigned readings. If students are unable to answer these questions, it will be assumed that they have not prepared the homework and will lose 1%. Consistent participation in class discussions, demonstrated knowledge of the assigned readings will also contribute to this portion of the final grade.

Discussion Board (200 points)

Before each discussion section, students are required to contribute a question or an answer to on an online discussion forum. Discussion boards will be posted via Canvas.

Description: Interpretive questions are open-ended and are concerned with textual meaning. They ask for your analysis of themes, figurative language, and symbolism within the narrative. They also call for discussion regarding the period, history, politics, and ethical questions that are relevant to the text. The open-endedness of interpretive questions—which often use phrases such as "why do you think" or "how did you interpret"—indicates that there may well be neither simply "right" nor simply "wrong" answers. The success of

a response is based on the evidence and reasoning students employ to support their analysis and judgment.

Close Reading Assignment (750 words; 200 points)

This assignment will test students' skills in close reading, especially as that skill pertains to works of poetry and short fiction. Students will be expected to analyze a text carefully and develop an argument regarding the whole of the text through a close reading. No outside sources may be used for this assignment.

Critical Analysis Paper (1,500 words; 300 points)

This assignment asks students to combine close reading skills with critical concepts and historical information introduced in class discussion and supplemental research. The goal is for students to produce a strong analytic argument supported by textual and contextual evidence.

Final Exam (200 points)

The final assessment for the course will be a take-home exam designed to assess students' critical analysis skills. In short essay format, students will respond to a series of prompts that address course concepts. Questions will require students to practice interpretation and analysis as they have done throughout the semester. Students will be assessed for thorough responses that clearly analyze textual evidence and make contextual connections.
