## **Course Outline**

PSY2012 is part of the General Education State Core.

### **• State Core Course Description •**

In this course, students will gain an introduction to the scientific study of human behavior and mental processes. Topics may be drawn from historical and current perspectives in psychology.

### **• State Core Student Learning Outcomes •**

By the end of this course:

1. Students will be able identify basic psychological theories, terms, and principles from historical and current perspectives.
2. Students will be able to recognize real-world applications of psychological theories, terms, and principles.
3. Students will be able to recognize basic strategies used in psychological research.
4. Students will be able to draw logical conclusions about behavior and mental processes based on empirical evidence.

### **• Social and Behavioral Sciences General Education Subject Area Objectives •**

Social Science courses must afford students an understanding of the basic social and behavioral science concepts and principles used in the analysis of behavior and past and present social, political, and economic issues. Social and Behavioral Sciences is a sub-designation of Social Sciences at the University of Florida.

Social and behavioral science courses provide instruction in the history, key themes, principles, terminology, and underlying theory or methodologies used in the social and behavioral sciences. Students will learn to identify, describe, and explain social institutions, structures or processes. These courses emphasize the effective application of accepted problem-solving techniques. Students will apply formal and informal qualitative or quantitative analysis to examine the processes and means by which individuals make personal and group decisions, as well as the evaluation of opinions, outcomes or human behavior. Students are expected to assess and analyze ethical perspectives in individual and societal decisions.

## Overview of PSY2012

This course is an overview of major topics in modern psychology, the scientific study of behavior and mental processes. As a first course in the discipline of psychology, it introduces some of the fundamental concepts, principles, and theories, with a consideration for the complexity of human behavior.

### • Course Goals •

1. To teach you the science behind psychology and how it differs from the media's interpretation.
2. To provide you with an introduction to the different areas within the field of psychology.
3. To teach you the concepts in the field and how to apply them.

### • Course Objectives •

By the end of this course, students will be able to...

5. describe a variety of major theories, topics, and issues in psychology.
6. identify the key roles that psychology plays in our everyday lives.
7. gain understanding of the scientific methods as applied to psychological research.
8. gain understanding of human behavior, emotion, and mental processes.
9. apply psychological knowledge to the real world in problem solving.
10. evaluate and synthesize psychological knowledge with critical thinking.

Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.

## Course Requirements

### • Unit Quizzes •

There will be four in-class unit quizzes during the semester. Quizzes are designed to assess your understanding of course material to date and to prepare you for the larger midterm and last exams. Each quiz contains 30 multiple-choice applied questions; each question is worth 1 point. The lowest quiz grade will be dropped by the end of the semester; thus, only three quizzes will be included in your final grade.

### • Assembly Midterm and Last Exam •

The midterm is an assembly exam administered **on Wednesday, 10/9 at 8:20PM in Turlington L007**. The last exam will be taken **in class on the last day of class**. You will be given 70 minutes total for the midterm (60 items) and 50 minutes for the last exam (40 items). The midterm and last exams will cover the first and second half of the semester, respectively. Please note that this course does **NOT** have a final exam in the final exam week.

## • Writing/Project Assignment •

There will be two writing assignments across the semester:

Writing Assignment #1 (30 points) will be due on **Friday, September 6, 2024 by the beginning of class (1:55 PM)**. You will be asked to annotate and “mark up” two chapters in the textbook. The purpose of this assignment is to give you the skills necessary to engage thoughtfully and deeply with course material across the semester. It will also double as a tremendously useful study tool for the first quiz and midterm exam. Finally, the goal is to learn how to read well; like any academic exercise, reading is a craft that requires cultivation of a certain set of skills and sensibilities. You will receive feedback on your annotations that guide you in how to more critically (and appreciatively) engage scientific publications.

Writing Assignment #2 (30 points) will be due on **Friday, November 8, 2024 by the beginning of class (1:55 PM)**. For this assignment, you will be asked to narrate a personally significant life event and analyze it with recourse to three psychological phenomena we have covered up to the due date. If you do not want to disclose a personal event, you may use a story found in literature, movies, television, or any other art. The purpose of this assignment is for you to embed psychological concepts in a story. Doing so will, hopefully, facilitate deeper understanding and internalization of the concepts and foster greater skill at applying these concepts to everyday experiences moving forward. If you have questions about the appropriateness of the event/story and phenomena, you are more than welcome to ask me in advance of the due date.

Specific rubrics for the writing assignments will be made available on the course Canvas.

## • In-Class Assignments •

There will be 12 in-class assignments (2 points each) across the semester. The two assignments with the lowest grade will be dropped at the end of the semester. In-class assignments will involve brief, informal engagement with course material, and you will find out the nature of the assignment on the specific class date. The point of these assignments is to encourage attendance and to check in on how students are thinking through conceptual questions in the course.

## • SONA Research Participation Requirement •

The Psychology Department requires that all students enrolled in PSY2012 participate in research. The deadlines for this requirement can be found in the document titled “SONA Research Requirement Instructions” (on our Canvas home page). Please note: The deadline to participate in research studies is *earlier* than the deadline to assign credits to this course. Completion of this requirement affects your course grade based on the amount of research credits you earn. Do **NOT** wait until the last minute to complete this requirement. The longer you wait, the harder it will be to get all the credits needed! If you are unable to participate in SONA research due to age or simply do not wish to participate in research studies, you may “opt in” to an alternative assignment.
