Course Outline

• Social and Behavioral Sciences General Education Subject Area Objectives •

Social Science courses must afford students an understanding of the basic social and behavioral science concepts and principles used in the analysis of behavior and past and present social, political, and economic issues. **Social and Behavioral Sciences** is a sub-designation of Social Sciences at the University of Florida.

Social and behavioral science courses provide instruction in the history, key themes, principles, terminology, and underlying theory or methodologies used in the social and behavioral sciences. Students will learn to identify, describe, and explain social institutions, structures or processes. These courses emphasize the effective application of accepted problem-solving techniques. Students will apply formal and informal qualitative or quantitative analysis to examine the processes and means by which individuals make personal and group decisions, as well as the evaluation of opinions, outcomes or human behavior. Students are expected to assess and analyze ethical perspectives in individual and societal decisions.

Overview of PSY2012

In this course, students will gain an introduction to the scientific study of human behavior and mental processes. Topics may be drawn from historical and current perspectives in psychology. This course is an overview of major topics in modern psychology, the scientific study of behavior and mental processes. As a first course in the discipline of psychology, it introduces some of the fundamental concepts, principles, and theories, with a consideration for the complexity of human behavior.

1. To teach you the science behind psychology and how it differs from the media's interpretation.
2. To provide you with an introduction to the different areas within the field of psychology.
3. To teach you the concepts in the field and how to apply them.

• Course Objectives •

By the end of this course, students will be able to...

1. Students will be able to identify basic psychological theories, terms, and principles from historical and current perspectives.
2. Students will be able to recognize real-world applications of psychological theories, terms, and principles.
3. Students will be able to recognize basic strategies used in psychological research.
4. Students will be able to draw logical conclusions about behavior and mental processes based on empirical evidence.

In-Class Recording

Course Requirements

• **Unit Quizzes** •

There will be four in-class unit quizzes during the semester. Quizzes are designed to assess your understanding of course material to date and to prepare you for the larger midterm and last exams. Each quiz contains 30 multiple-choice applied questions; each question is worth 1 point. The lowest quiz grade will be dropped by the end of the semester; thus, only three quizzes will be included in your final grade.

• **Assembly Midterm and Last Exam** •

The midterm is an assembly exam administered **on Wednesday, October 9th at 8:20PM in** Turlington L007. The last exam will be taken in class **on the last day of class**. You will be given 70 minutes total for the midterm (60 items) and 50 minutes for the last exam (40 items). The midterm and last exams will cover the first and second half of the semester, respectively. Please note that this course does **NOT** have a final exam in the final exam week.

• **Essay Assignments (2)** •

There will be two essays this semester related to Chapter 7 on memories and Chapter 14 on psychological disorders. Together, these essays will account for 21% of your final grade, or 30 points each. Each essay must be in APA format and 3-4 pages double-spaced. The use of ChatGPT or other AI software is forbidden for these essays. The purpose of these assignments is to bridge psychological concepts and theories with content from your own life, teaching you how to critically apply psychological concepts when reflecting on your day-to-day experiences. Both assignments require creativity, critical thinking, and knowledge of the relevant subjects from the textbook chapters. Rubrics will be posted on Canvas.

Essay 1 – Memory Malleability

Memories can interfere with each other or fade over time. Our schemas can bias our memories of events, and misleading information can lead us to remember occurrences that never happened or remember them differently. For this assignment, you will be tasked with choosing and reflecting on an episodic memory. It must involve an event or experience that happened over three years ago, took place over a span of 30 minutes to 2 hours, and included at least one other person who can also recall and verify the memory.

Remember and write down as much vivid information as you can, then share the details of your memory with the other person who was there. Pay special attention to any details you got wrong or omitted. For the essay, summarize how your memory compared to the other person's (e.g., was your memory perfect? Was it distorted in some way?), discuss what factors may have led to the distortion (external suggestions from media or news coverage, infantile amnesia, event plausibility, source monitoring issues, etc.), and finally, reflect on what the exercise made you feel about the malleability of your memory and how memories are reconstructed or change over time.

Essay 2 – Diagnose a Character With A Psychological Disorder

Write a paper diagnosing a character [from a movie, TV show, book., comic book, video game,...] with one of the psychological disorders we discussed in class. Use evidence from their life to show how they meet the various diagnostic criteria and symptoms. You must provide sufficient evidence to support your diagnosis to receive full points. Papers must be in APA format, and include at **least one source** outside of the textbook (in this case, websites like Wikipedia, television episodes, fictional books, and gossip sites can be used as sources). It should be 3-4 pages (double spaced) in length. Please refer to the rubric and materials on Canvas for all requirements.

• In-Class Assignments •

During some class lectures, we will pause for 7-10 minutes for a brief, in-class assignment. These occur at random and are not announced ahead of time. These assignments will consist of short reflection or knowledge-check questions related to that day's lecture. There will be a total of 12 in-class assignments throughout the semester and the 2 lowest scores will be dropped at the end of the semester.

• SONA Research Participation Requirement •

The Psychology Department requires that all students enrolled in PSY2012 participate in research. The deadlines for this requirement can be found in the document titled "SONA Research Requirement Instructions" (on our Canvas home page). Please note: The deadline to participate in research studies is *earlier* than the deadline to assign credits to this course. Completion of this requirement affects your course grade based on the amount of research credits you earn. Do **NOT** wait until the last minute to complete this requirement. The longer you wait, the harder it will be to get all the credits needed! If you are unable to participate in SONA research due to age or simply do not wish to participate in research studies, you may "opt in" to an alternative assignment.
