State Core Course Description

PSY2012 is part of the General Education State Core.

In this course, students will gain an introduction to the scientific study of human behavior and mental processes. Topics may be drawn from historical and current perspectives in psychology.

- 1. Students will be able identify basic psychological theories, terms, and principles from historical and current perspectives.
- 2. Students will be able to recognize real-world applications of psychological theories, terms, and principles.
- 3. Students will be able to recognize basic strategies used in psychological research.
- 4. Students will be able to draw logical conclusions about behavior and mental processes based on empirical evidence.

Course Goals

- 1. To teach you the science behind psychology and how it differs from the media's interpretation.
- 2. To provide you with an introduction to the different areas within the field of psychology.
- 3. To teach you the concepts in the field and how to apply them.

Social and Behavioral Sciences General Education Subject Area Objectives

Social Science courses must afford students an understanding of the basic social and behavioral science concepts and principles used in the analysis of behavior and past and present social, political, and economic issues. Social and Behavioral Sciences is a sub-designation of Social Sciences at the University of Florida.

Social and behavioral science courses provide instruction in the history, key themes, principles, terminology, and underlying theory or methodologies used in the social and behavioral sciences. Students will learn to identify, describe, and explain social institutions, structures or processes. These courses emphasize the effective application of accepted problem-solving techniques. Students will apply formal and informal qualitative or quantitative analysis to examine the processes and means by which individuals make personal and group decisions, as well as the evaluation of opinions, outcomes or human behavior. Students are expected to assess and analyze ethical perspectives in individual and societal decisions.

In-Class Recording

Course Requirements

<u>Unit Quizzes</u>: There will be four in-class unit quizzes during the semester. Quizzes are designed to assess your understanding of course material to date and to prepare you for the larger midterm and last exams. Each quiz contains 30 multiple-choice applied questions; each question is worth 1 point. The lowest quiz grade will be dropped by the end of the semester; thus, only three quizzes will be included in your final grade.

<u>Assembly Midterm:</u> The midterm is an assembly exam administered **on Wednesday, October 9**th @ **8:20PM** in TURL L007. You will be given 70 minutes total for the midterm (60 items). The midterm will cover the first half of the semester.

<u>Final Exam</u>: The last exam will be taken in class **on the last day of class**. You will be given 50 minutes for the last exam (40 items). The final exam will cover the second half of the semester. Please note that this course does **NOT** have a final exam in the final exam week

Writing Assignments: There will be two writing assignments throughout the semester. These assignments are designed to get you to apply what you have learned during class and to synthesize the information learned throughout the course. You can find a description of each assignment on Canvas. Please submit all written assignments in .doc or .docx file formats to Canvas. I will not grade written assignments that I cannot open, nor accept hard copies. Each writing assignment will be worth a total of 30 points. Late submissions will be penalized by 2 points for each 24-hour period after the assignment is due. Assignments that are more than 48 hours late will not be accepted or graded.

<u>In-Class Assignments</u>: There will be a total of 12 short in-class assignments throughout this semester. These will be given randomly, and are not listed under the tentative schedule. The in-class assignments are designed to reinforce the content of the class. Each assignment is worth 2 points. Only 10 of these assignments will count toward your final grade. The 2 in-class assignments with the lowest grade at the end of the course will be dropped.

SONA Research Participation Requirement: The Psychology Department requires that all students enrolled in PSY2012 participate in research. The deadlines for this requirement can be found in the document titled "SONA Research Requirement Instructions" (on our Canvas home page). Please note: The deadline to participate in research studies is *earlier* than the deadline to assign credits to this course. Completion of this requirement affects your course grade based on the amount of research credits you earn. Do **NOT** wait until the last minute to complete this requirement. The longer you wait, the harder it will be to get all the credits needed! If you are unable to participate in SONA research due to age or simply do not wish to participate in research studies, you may "opt in" to an alternative assignment.
